Motion by Mr. Erickson seconded by Mrs. Hill to approve the agenda changes.

Mrs. French shared the Stay Open Plan for North Warren for Fall 2021. Masks were discussed, HHHN and Warren County DOH want masks to be worn inside by everyone Michele's plan is masks = movement but it will be a fluid and flexible plan. All students are expected to attend in-class every day, if placed in quarantine the teachers will get work to them. Masks are required at all times on transportation and seats will be assigned. The plan will be online for everyone to review.

Mr. Buckman was about Zoom in classrooms if students are quarantined. Mrs. French reports that she met with teachers last year and they wanted 1:1 instruction. Mr. Buckman felt the quarantined students got less for education. Mrs. Kelly reports that many elementary principals had moved away from Chromebooks to teach as it was not good for students to be in front of the computer all day.

Mrs. French reports the hours will be the same as pre-COVID. Mr. Martin reports the 7-12 teachers will have "office hours" this year to be able to meet with students.

Mrs. French reports the county has put in for a grant to get testing machines in each school. Return to school after an illness was discussed. She reports it is her duty to keep people safe.

Mrs. Swan asked when the masks will come off. Mask discussion followed. Some folks are for masks some are against.

Mrs. French reports are Q & A will be held on Thursday regarding the Plan.
