Mr. Lail reports that we would have to borrow some money to complete the entire project.

Mrs. McAvey reports the district will be using the new voting machines provided by Warren County. Training will be soon.

Mr. LaPell stated the school should lighten the budget and do only what is needed.

Mrs. Swan questioned if students can play a sport as credit for physical education class. Concerned about the low number of girls in sports.

Mrs. Hill asked if there has been any more discussion on a soccer merger with Johnsburg and Minerva. Mrs. French reports that is currently on hold.
